WHO MOVED MY CHEESE? BY SPENCER JOHNSON

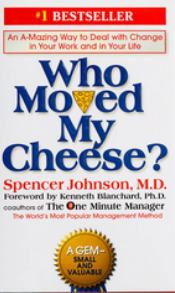
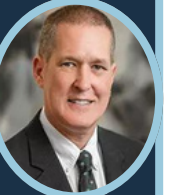
